## PAYMENT

A **non-refundable** deposit in the amount of 50% of the total cost is due upon signing the rental agreement. The remaining amount is due 7 days prior to the event.

We accept cash, check and all major credit cards. **There is a \$25 NSF fee on all returned checks. Please make checks payable to Erika Luening.**

## ACCESS, SPACE, AND POWER FOR PHOTO BOOTH

Client will arrange for an appropriate space for the photo booth at the event venue (6'W x 6'L x 6'H). If event is out doors Client agrees to provide a level, concrete like surface sheltered from the elements.

Client is responsible for providing power for the photo booth (110V, 10 amps, 3 prong outlet).

## DATE CHANGES AND CANCELLATIONS

Any request for a date or time change must be made in writing at least 15 days in advance of the original event date. Change is subject to photo booth availability and receipt of a new signed Rental Agreement. Charges may be incurred for date and time changes. If there is no availability for the alternate date, the deposit shall be forfeited and event cancelled. Any cancellation occurring less than 15 days prior to the event date shall forfeit all payments received. **\*Please note: the deposit is non-refundable. Under no circumstances will your deposit be refunded.\***

## DAMAGE TO PROVIDERS EQUIPMENT

Client acknowledges that it shall be responsible for any damage or loss to the Providers equipment caused by: a) Misuse of provider's equipment by Client or its guest, and/or b) Any theft or disaster.

Client acknowledges that we, NOLA Paparazzi Photo Booth, reserve the right to terminate any event, during the event, due to unruly conduct. This includes any behavior causing damage to the booth (ie. punching, kicking, slapping buttons, etc.). All children **MUST** be accompanied by an adult at all times in and around the photo booth. You will not be refunded in any way for lost time.

## INDEMNIFICATION

Client agrees to, and understands the following: a) Client will indemnify Provider against any and all liability related to Client's event during or after Client's event. Client will indemnify Provider from the time of service and on into the future, against any liability associated with Client and guests. b) Client will indemnify Provider against any and all liability associated with the use of pictures taken within the photo booth of its representatives, employees, or affiliates at the Client's event.

## MISCELLANEOUS TERMS

If any provision of these terms shall be unlawful, void or for any reason unenforceable under Contract Law, then that provision or portion thereof, shall be deemed separate from the rest of this contract and shall not affect the validity and enforceability of any remaining provisions, or portions thereof. This is the entire agreement between Provider and Client relating to the subject matter herein and shall not be modified except in writing, signed by both parties. In the event of a conflict between both parties, Client agrees to solve any arguments via arbitration. In the event Provider is unable to supply a working photo booth for at least 80% of the Service Period, Client shall be refunded a prorated amount based on the amount of service received. If the printer fails to print out photos on site the Provider will be allowed to give a CD to the Client where their guest can download the digital files for their own use. If no service is received by Client due to circumstances out of Provider's control, Provider's maximum liability will be the return of all payments received from client. Provider is not responsible for any consequential damages or lost opportunities upon breach of this agreement.
